#### **Sunday, June 14, 2009 – Harford County Maryland Model Railroad Visits**

Sunday, June 14, 2009 from 1 PM to 5 PM. In conjunction with the new Chesapeake Division, three HO model railroads in Harford County, Maryland will be open for visitation. Alan Anderson models the 1920's with all steam power and heavy influence of logging. Alan has a new unique control system that is not DCC but a hybrid DC with wireless remote control. Ken Poznaniak's DCC, two level, contemporary layout features long trains, automated coal loading at the mine and rotary dumping at the power plant. Dave Renard, MMR's, mid-sixties railroad contains a lot of scratch-built structures, rolling stock and trackwork and is DCC controlled. **Non-NMRA members are invited.** More information and directions will be in a future newsletter and on the website when available.

## Division 11 Happenings

This (short) newsletter is being sent to the entire division as it contains two ballots. First, we have three nominees for the three Director positions. Gale Smith has decided not to run again. The second ballot is for two changes to the Division By-Laws suggested by the MER board. The first is to Article II, Section 1 to spell out the counties in the Division rather than state which divisions form the boundaries. The second is to change the wording of Article XI, Section 1 to state that new By-Laws will take effect after a "review" by the MER board, not "approval".

The Division officers have unanimously recommended both of these changes be accepted by the division and has voted to allow electronic (e-mail) voting on both ballots.

## Division By-Law Ballot

The following two changes have been proposed to the Division By-laws. A complete copy of the old and new by-laws can be found on the division website. If you would like a printed copy, please contact Jeff Warner. You may vote to accept these changes or reject them as a group. Votes must be received by Friday, June 26, 2009.

The following are the NEW wordings for the two affected sections. All other sections remain the same.

### **ARTICLE II - Territory**

**Section 1.** The Susquehanna Division shall be comprised of the following counties in Pennsylvania:

Adams, Berks, Blair, Cambria, Carbon, Centre, Columbia, Cumberland, Dauphin, Huntingdon, Juniata, Lackawanna, Lancaster, Lebanon, Lehigh, Luzerne, Lycoming, Mifflin, Monroe, Montour, Northampton, Northumberland, Perry, Pike, Schuylkill, Snyder, Sullivan, Susquehanna, Union, Wayne, Wyoming and York.

### **ARTICLE XI - By-Laws Changes**

**Section 1.** These By-Laws may be amended by a two-thirds vote of the membership responding to the mail ballot. The Board of Directors may elect to allow electronic ballots in addition to mail ballots. Proposed changes must be published in the division newsletter not less than fourteen (14) days prior to any vote. The amendment(s) will take effect after review by the MER Board of Directors.
