2010 Susquehanna Division 11 Events

Saturday, May 22, 2010, at 1 PM. MER general contest chairman Martin Brechbiel will present 2 clinics on judging contest models using AP guidelines. The first will be oriented towards becoming a judge and the second will be oriented towards modelers entering contests. The clinics will be at one of two locations, depending on the number of interested members, in the York-Harrisburg area. YOU MUST REGISTER FOR THIS EVENT IN ADVANCE. Saturday, June 5, 2010 at 9:30 AM. We will host a joint meet with the Chesapeake division with morning clinics at the Camp Hill Giant Food Store and afternoon open houses. More details will be presented in a future issue, but there will be two or three clinics and tentatively six open houses.

Saturday, Sept 25, 2010 at 9:30 AM. We will host a joint meet with the Philadelphia division with two morning clinics and afternoon open houses in the Allentown area. More details will be presented in a future issue.

Friday, October 1, 2010, and Saturday, October 2, 2010. We will co-host with the OPSIG the Lehigh-Susquehanna Operations Weekend 2 (LSOPS 2). This will give members and visitors a chance to operate some of the fine layouts found in the division, with a group in the Lehigh Valley (Allentown area) and a group in the Susquehanna Valley (York-Harrisburg area). No experience will be required to participate, but you will need to register for the event. More details will follow in a future issue, including how to register.

MER Judging Clinic by Martin Brechbiel MER General Contest Chairman

As you might remember from a past issue of The Local, I stated that I would be initiating a required training regimen for all current and future Judges that would be made available to all members and Divisions this calendar year. A comprehensive program for training Judges for the AP program and Contest Room across the MER region that travels to all of the Divisions was approved by the MER Board of Directors. So, now that opportunity is coming to the Susquehanna Division!

This program includes a series of presentations and lectures accompanied by some hands-on practice sessions. The intention is the achieve uniformity, consistency, and to provide a level playing field for all modelers and entrants participating in the AP program and thus also generate trained and certified Judges for the entire MER Region. It's clear that we have a limited number of experienced Judges that are also well knowledgeable of the judging guidelines, and just what the really in those same guidelines. We'll review every category of judging, what is and is not in the guidelines, what the Judges look for and what they are supposed to ignore(!), and hopefully dispel more than a few myths. Your attendance will qualify you for apprenticeship in judging at the MER 2010 convention, September 30 - October 3, in Princeton, NJ where you'll be teamed up with an established Judge for the day. These sessions will serve as entry points for the certification of all Judges for the MER such that we can all have confidence in both the fairness and uniformity of Judging and the AP program across the MER not only short-term, but for the future of our region.

A complementary clinic/program for modelers that want to participate in the AP program and enter their models for judging in contest rooms is also part of this package deal. Paperwork & forms are perceived as an impediment to entering models into the Contest Room. As has been noted before, Judges only have ~7-9 minutes per category per model. Having the "right stuff" on your paperwork can only help you, and I want you to get those Merit Awards! One thing we're going to try to do is to establish a "Help Desk" to provide guidance to entrants with their paperwork at the MER Convention to have someone read over your forms, make constructive suggestions, etc. This is not to "pre-Judge" entries or to prepare the paperwork for others. I'm also making a number of operational changes to the MER Contest Room regarding overcrowding, excessive noise, and safe operations in general which we can also talk about since good ideas are always appreciated. I've also initiated a new MER Yahoo Groups - the MER Mailbag -- http://groups.yahoo.com/group/MERMailbag/ to replace the prior site. I encourage you all to visit, join, and make use of the site. Contest Experience Surprise by James A. Mattern



I studied the judging section of the achievement program to see how the model would be judged. I took a few close-ups with my digital camera to see how many defects I could see. I started to cringe a bit examining the photos. With so many defects from repairs, construction defects, and normal handing of the locomotive over its years of service on the Stiegel Valley (Model railroad club located in Manheim, Pa), I had some apprehension about entering. I scored my model based off the AP judging guidelines and thought it would fall in the range of seventy five to eighty five points. However, I've never judged a model contest or entered one. I knew all the problems and shortcomings, but it was time to really see what others thought of my work. I also wanted to gain insight on how I could improve my modeling skills, so I began filling out the necessary paper work to enter the contest.

I started writing down what I did for construction and found that I had filled almost three pages of information down. With All the photos and drawings I was going to use, it was about ten pages of information. I knew I had to condense it down, after all the judges are not just looking at my entry they're looking at all the entries. To be courteous to others, I broke the information down by the sections on NMRA form 902 and some of it was omitted. I had condensed it down to about a page of written


material with enough photos and to convey how I followed the prototype and built the model. I also followed what Norman Frowley, MMR, wrote in the September 2009 issue of SCALE RAILS and organized everything into a small three ring binder. It was time to enter the contest.

I got up on a cold and wet day and made the trek from Lebanon to Hagerstown. When I got to the convention, I found things to be warm and friendly. After registering, I headed for the contest room. I was asked a couple of questions, which got the model judged for two additional awards, Clyde Gerald Kit-Bash Award, and The Philadelphia New Modeler. I thought O.K. this would increase my chances of achieving something for my effort. I would visit the contest room over the course of the day to see what else was being entered. Chuck Hladik's beautiful and massive O scale Rutland RS-3 arrived first. I thought wow! No glue marks or any visible construction marks. It was one pristine RS-3. Later in the day P.J. Mattson critters showed up. I forget how many he did enter, but the construction was near perfect on all of them. Since construction carried the most points (forty), I thought one of the critters would be the winner. I put the contest in the back of my mind and enjoyed attending the clinics, and waited till before the banquet to see how I did. I was pleasantly surprised when I checked my score of eighty-nine, four more points than I had given myself after studying the photos. What amazed me more is when I checked Chuck Hjadik's, and P.J. Mattson's scores mine was the highest. It was a surreal moment, I think I checked the scores three or four times till it sank in that I won, but even more surprises were coming.

The awards were given out for the first place winners in their respective categories, and I accepted for the diesel locomotive. I sat admiring my plaque, when they announced the Philadelphia New Modeler Award. After receiving this award, I started heading back to my seat. Martin Brechbiel said, "Wait a minute James, I have another one for you." I had another surreal moment and wanted to pinch myself to make sure I wasn't dreaming. I then turn around and accepted the Clyde Gerald Kit-Bash Award. I was overwhelmed and honored by all the awards. Although the model wasn't perfect in my eyes it was a very good model to others. Now that I know what the judges are looking for I can improve upon my modeling skills, and start pursuing my MMR.
